## OBJECTS OF THE SCHOOL.

The School is to be conducted as a Public Secondary Day School for Girls, under the regulations and inspection of the Board of Education.

Pupils will be admitted from the age of 10 years and upwards.

The Course of Instruction includes-

Holy Scripture, Reading, Writing, English Literature, Composition and Grammar, History, Geography, French, German, Latin, Mathematics, Botany, Physics, Nature Study, Art, Needlework, Singing and Physical Exercises, with such other subjects as may be arranged from time to time.

### BUILDINGS.

The buildings, which provide accommodation for about 250 girls, are situated in Holly Walk, Enfield.

The following provision is made for the Secondary School:-

Central Hall, Nine Classrooms, Art Room, Science Laboratories, Preparation Room, Domestic Room, Lavateries, Cloak Rooms, etc.

## FEES.

The School Fees, payable in advance to the Enfield Branch of Lloyds Bank, are £2 2s. 6d. per term, including the use of books and stationery.

All pupils, other than new pupils and scholars, who have not paid their fee before the first Monday of each Term, and new pupils whose fees are unpaid upon the second Monday after admission, will be excluded from the School.

Parents or Guardians will be required to notify the Head Mistress before Mid-term of their ntention to remove a pupil at the end of that term, or, in the alternative, to pay half a term's fee.

#### GENERAL REGULATIONS.

The School Hours (subject to alterations) are from 9 to 12.15, and 1.55 to 3.55

Saturday is a whole holiday.

The year is divided into three terms of about thirteen weeks each, with about seven weeks holiday in the Summer, three weeks at Christmas, and three weeks in the Spring.

Applicants for admission are required to pass an Entrance Examination, which will be held at the beginning of each Term.

Forms of application for admission must be filled in and signed by the Parent or Guardian, and sent to the Head Mistress.

No pupil will be allowed to attend the School from a house in which there is a case of infectious disease; and if the pupil has suffered from or been in contact with such disease, a Doctor's Certificate is required before the pupil can return to School.

All ordinary books and stationery will be provided, but the books remain the property of the School, and therefore care must be taken of them.

Any careless treatment or wilful damage of School property by a pupil must be paid for by the Parent or Guardian of the Pupil.

There is a playing field attached to the School.

Provision is being made for the following games :-

Hockey, Tennis, and Net Ball.

A report on the work of each pupil will be sent to her Parent or Guardian at the end of every term.

Pupils will be required to wear the School hat-band when going to and from School, and to keep a pair of shoes at School for use therein; and are also requested to provide a School Gymnasium Dress.
