Careers Education, Information, Advice and Guidance (CEIAG) Policy

Introduction

Principles of the Policy Careers Education, Information, Advice and Guidance (CEIAG) is defined as: 'planned activity that uses the context of work to develop knowledge, skills and understanding through the experience of work, learning about work and gaining employability skills.'

Enfield County School for Girls is committed to maximising the benefits for every student, in the development of the whole school approach to work-related learning. The school recognises that there should be significant Careers Education, Information, Advice and Guidance for all students and more individual input for particular girls. The school has a responsibility to promote Careers Education as part of the learning entitlement for all students. We will support all students in making well-informed decisions by providing access and opportunities to a variety of options that will help them achieve their ambitions.

Aims and Objectives

The aims for work-related learning focus on the provision the school makes for opportunities for students to prepare for adult and working life. These include:

Careers Education, Information, Advice and Guidance (CEIAG) at Enfield County School for Girls (ECSfG) will:

- · based on the Gatsby Benchmarks for Good Careers Guidance;
- improve educational standards through using contexts that improve motivation and attainment for all students;
- ensure that students follow courses and programmes which are appropriate to their longer term aspirations and needs
- · improve students understanding of the world of work and its demands
- · improve the quality of provision and guidance
- · increase access and choice for all students
- · improve the transition of students from school to adult and working life

The key objectives for Careers Education, Information, Advice and Guidance (CEIAG) learning are:

- to raise levels of attainment through high quality Careers learning for all students
- to develop a range of opportunities which enhance the curriculum; to promote greater awareness for students about the world of work
- · to develop the key skills of employability and enterprise
- to develop a range of appropriate and relevant activities which assist in raising all students' aspirations and achievement
- to promote awareness and understanding of work, industry, the economy and the local community
- to develop skills, attitudes, concepts and knowledge of careers including career management skills and knowledge of the local labour market (LMI) and the wider world
- to develop students' personal and social skills in relationships in a range of contexts
- to develop effective links with key partners and local industry
- to provide students with informed and impartial guidance on the choices available for education, training and employment

Career Insights

Due to our work with external partners we fulfil the requirement for all students from years 7 to 11 to have at least one meaningful encounter each year with an employer and for all students to have experience of at least one workplace by the age of 16. This could be through virtual work experience, employer assemblies, mock interviews etc.

Parent/Carer Engagement

At ECSfG we actively promote and welcome parent/carer involvement through our School website, Social media (Twitter etc), CEIAG events, newsletters, careers support at Options evenings and open evenings.

Resources

CEIAG has a number of resources that can be used by the students:

- Careers library with a range of literature including books, leaflets, college and university guides and reading books on topical careers issues and skills required for the world of work
- Information is regularly added to MS Teams and the School Website to provide students and stakeholders with relevant information and opportunities.
- Form Tutors
- PSHE and Personal Development Teachers
- Careers Leader

The budget for careers is allocated on an annual basis and is managed by the Careers Leader.

Staff Development

The Careers Leader has achieved the qualification for the OCR Accredited Level 6 Careers Leader qualification. CPD is offered to relevant staff as opportunities arise. The Careers Leader is a Gatsby advocate and a member of the Careers Development Institute (CDI). Staff development is monitored by line managers.

Curriculum

At Enfield County School for Girls we deliver Careers Education through a variety of opportunities:

- Careers lessons in Year 7 and Year 9 Personal Development lessons (PD);
- Careers lessons in Year 11 Personal Development Lessons (PD);
- Annual Careers Fair
- Careers Library based in the Library at Holly Walk (resources are updated on a regular basis and cover a breadth of careers and information on many different pathways etc.;
- National Careers website;
- ASK Apprenticeship advisor (assemblies and workshops)
- DWP school advisor support (assemblies and workshops);
- Careers assemblies;
- Form time activities;
- Workplace visits, FE and HE visits;
- Duke of Edinburgh Award;
- CV and Personal Information Statement (PIS) writing support;

Assessment

At ECSfG, Careers learning is assessed using the learning outcomes from the CDI Framework for Careers, Enterprise and Employability Education. Student progress and the quality of work is assessed through a range of assessment methods including self-assessment, peer assessment and teacher assessment.

Monitoring and Evaluation

At ECSfG we monitor progress towards achieving the Gatsby Benchmarks and is evaluated annually using the online Compass tool (as recommended in the Careers Guidance and access for education and training providers Jan 2018). The CEIAG development plan is based upon the outcomes of the Compass audit.

The effectiveness of our careers will be reflected in the higher number of students progressing to positive destinations. We use destination data to assess how successfully students make the transition into the next stage of education, training or employment. The data will be analysed by the Careers Leader with key actions fed back to SLT and Governors. Action points will be included in the annual CEIAG development plan.

A designated governor has responsibility for overseeing the quality of careers guidance. The Careers Leader reports to the Governor for CEIAG.

The CEIAG policy is reviewed on an annual basis by the Careers Leader. This is ratified by Governors.
